May Board Meeting Minutes: Motion to approve by Mark L., 2nd by Ken H.

Treasurer's Report: Dennis B.: Elida provided a spreadsheet to Dennis for January –May 31. Cash on hand: \$7,956.02. Savings: \$20,754.26.

Advocacy: Tina S.: She met with staff at the County of Fresno meeting. She brought up a number of issues with routes we ride. The bridge repairs on Old Millerton Road time frame has been moved back. She brought up potholes on the Trimmer Springs Bridge as well as the sweeping of the bike lanes in the County. She is going to obtain the sweep schedule. The status of the bridge at Broken Bridge hill—there appears to be disagreements with the County. It was supposed to be designed as a widened 2 lane with bike/pedestrian lanes on each side. Now they are changing it to a 4 lane with the possibility of adding a pedestrian bridge at a later date. She is working with the people putting together the Great Central Valley Bike Route, which extends along the valley floor from Shasta to Bakersfield. They are fine-tuning the route. They are fundraising to start a website.

Tour de Femme: Janet L.: October 23. \$2,961 has been raised from the jersey fundraiser so far. Will use any new/current funds raised to fund the ride.

Kirch Flat: Mike Q.: August 21. Start/finish will be Paso Tiempo Park. Diana D. advised she is working on volunteers.

ELR: Henry P.: November 6. They had their first meeting and assignments have been made for the committee. A meeting will be set with the new Raymond Community Service Officer. The site fee is up, but they have made improvements. There is a suggested shorter ride from the first rest stop and back.

Grizzly Century: Dennis B.: October 2. He had a meeting with the North Fork group. They are adding a gravel section with approximately 47 miles of gravel. They will coordinate rest stops. The Lions Club will handle breakfast. They will use the Town Hall instead of the school. He will need to confirm the after ride meal. FCC will help with SAG and radio and they may need to use some of our equipment.

BLDC: Dennis B.: October 9. Start/finish at the Hampton Inn, Clovis. They will have lower room rates for riders. FACT Team will help work the start/finish.

Tour de Lakes: Dennis B.: July 31. Gia will find out if Mary Stubblefield can man the rest stop again.

Storage update: Diana D.: She has new labels made. All items must be checked out through her. She is putting together an inventory. She is asking everyone to return all FCC items.

Sacramento Ride: Ken H. November 13. Details to follow.

William Saroyan Ride: Dennis B.: August 31. Fundraiser for the William Saroyan Foundation. They want to know if FCC wants to help. They want to set up a Zoom meeting for further discussion.
