Meeting Opened: 6:40PM, called to order by President Dennis Ball

Meeting Protocol Reminders: Whomever has the floor has the floor. No interruptions.

Moment of Silence: For Adela Santana Mulooly. Dennis has credited back her TDF entry fees. There is a meal train and GoFundMe set up on Facebook.

SeptemberBoard Meeting Minutes: Motion to approve by Joe C.; 2nd by Dennis B., Approved.

Treasurer's Report: Elida G.: Approx. \$30K checking; \$10,000 in savings. The Articles of Incorporation have been sent to the State of CA and things are moving forward. Quickbooks is underway. Once the tax issues are resolved, will work on the 501C3 status.

Advocacy: Tina S.: Cycling bills: The Governor did not sign the 4-way stop/yield for cyclists. He did sign A1909—Bike Omnibus Bill—prohibits mandatory bicycle registrations; requires drivers to change lanes when there are two or more lanes in each direction; clarifies bicycles are allowed to cross with the pedestrian walk signs; prohibits cities from disallowing e-bikes in the bicycle lanes. AB2264 requires jurisdictions to set the walk light to allow pedestrians to cross first when there are stop lights with a walk feature. AB1946 requires CHP to do on-line safety training for e-bikes. Measure C is on the ballot for next month. ½ cent sales tax has a set-aside for cycling issues. There has been no real Measure C campaigning. It does not expire until 2026. 10/11/22 there is a Zoom meeting with the Bike Café. It is educational/informative regarding the Measure C renewal—winners and losers.

Grizzly Recap: Tony Inderbitzen: (Provided to Dennis): He was able to secure \$7,000 in sponsorships. There were 20% more riders this year than last. 51 were

gravel and 55 were road. Most of the no-shows were rollovers from last year. The free beer was a hit. Jerseys were available for order.

Budget Committee Meeting: Dennis B.: Will be held on November 9. This will be a closed board meeting at Victory Grill.
