**July Board Meeting Minutes:** Read and motion to approve upon elimination of one duplicate paragraph by Joe C., 2<sup>nd</sup> by Elida G., approved.

**Advocacy Report:** Nick Paladino assist for John McCracken: Four projects being partially funded by SB1. A measure to strike down SB1 will be on the November ballot. 2 sections planned for overlay on the C2K route: 2.7 miles of Burrough Valley Road and east of Tollhouse uphill to Sandpiper Lane and Huntington Lake Road and Hwy. 168 (Big Creek) 3.8 miles total. The contract has already been awarded for 7 segments starting in July. SB1 money is to supplement Measure C.

Willow Avenue is slated to have 3 lanes both sides to Shepherd. The City of Clovis is to make 3 lanes from Shepherd to Copper. Willow northbound is planned for next summer. SB1 also helps fund the ACP, which promotes bicycle and pedestrian safety.

**C2K Critique:** Dennis B.:

Dennis thanked all workers, including rest stops, SAG, FACT after ride meal and Mike's Grill. There were issues regarding the documentary being filmed. Dennis apologized for not making it known to everyone that Tyler Pearce would have a documentary film crew following him on the C2K route, which was given approval by Dennis before the ride.

C2K rider rules were tabled for a later discussion.

Next year there will be a C2K committee.

Will stick with the 3<sup>rd</sup> week in June for next year's date.

**Tour de Lakes:** Henry P.: The date was rescheduled due to the fires to August 18. Dennis will see if we will need to resubmit permits. He will also check to see if we can get the ball diamond at the community center for parking. Dennis will check with the radio crew as well. Mary Stubblefield has stepped in to handle the lunch stop, as Lori Cherry has a conflict with the new date. There will be a water stop at Wishon this year.

**Bob Brooks Memorial Ride:** Will be in coordination with the Tour de Lakes Ride on August 18 starting from the Shaver Lake Community Center and heading out to Courtwright. Riders are invited to use the FCC rest and water stops.

**BLDC:** Angelo Q.:

1. Sponsorships—done.
2. Mechanics of the event—doing OK.
3. Volunteers—will be requesting commitments in August.
4. Discussion with Chuck Bramwell: Expired Hammer products have been an issue on other rides (not ours). He will make sure no products are expired.
5. Curfew: He took out the "strictly" 12 am cutoff time. The course will close at 12 a.m., but people can continue to ride to finish. He says he will be flexible on times.

**Grizzly Century:** Dennis B.: He has a meeting Monday with the coordinators. Dennis will be doing coordination with the local people. FCC will do food purchase. Kevin will handle SAG. The Town Hall and the school are reserved. The Lions Club will be cooking breakfast for sale. They might need help with registration. The date is October 6, the week before BLDC.

**FCC Annual Picnic:** No report, but it will be held on September 1 at Railroad Park in Clovis at 3 pm.

**Time Trial:** Dennis B.: August 11 starting from Sandals in Friant. There were 35 participants last month.

**Gravel Grinder:** Henry P.: November 17 in Raymond, CA. There is \$10 camping at the venue. He is looking for off-road SAG that has ground clearance. He is working on an event page. He is looking for volunteers.

**New Business:**

Angelo Q.: Ariel Cleofus, the FACT president is not on the FCC Board messenger or email. Dennis will make sure he is added.

Ken H.: Asked about the club sponsoring a mile at \$200 a mile on a route Bob Brooks rode a lot. Perhaps on the Sierra Cascade route. There is a map on Adventure Cycling.com.
